In the early 1930s, Isabel and Monroe Smith witnessed the transformative power of hostelling during a trip to Europe. This new approach to youth travel emphasized accessibility – empowering young people, regardless of origin and means, to explore the world under their own initiative and immerse themselves in unfamiliar surroundings. Inspired by this vision, the Smiths opened the first U.S. youth hostel in Northfield, Massachusetts in 1934, laying the foundation for what would become HI USA.

Ninety years later, the travel landscape and hostelling have evolved, but our passion and mission have endured – “to help all, especially the young, gain a greater understanding of the world and its people.”

This year’s annual report celebrates 90 years of hostelling in the United States. From the bike clubs of yesteryear to today’s volunteer-led guest experiences, from the life-changing Trips Program to travel scholarships that open doors for young people to explore the U.S. and world – HI USA’s achievements have only been possible thanks to our dedicated community of members, donors, volunteers, partners, guests, and staff. This is a tribute to the vibrant hostelling community that believes in the transformative power of the hostel stay.

Our 90th year was one of remarkable growth and impact. In 2024, we welcomed 620,711 overnight stays across our 14 hostels, a testament to the continued appeal of our mission and the experiences we offer. Our volunteer program expanded to 422 dedicated volunteers, who helped enrich guest experiences, select scholarship recipients, and provide organizational leadership. We awarded 55 travel scholarships through our Explore America, Explore the World, and Explore the World: First Passport Edition programs, helping launch new journeys and dreams.

We were honored once again at Hostelworld’s Hoscars Awards as the Best Hostel Chain in North America, with special recognition for HI Boston and HI New Orleans. Our Explore the World Travel Scholarship program was also named as a finalist in the Global Youth Travel Awards, awarded by the World Youth, Student and Educational Travel Confederation. Through these milestones, we continued to open doors to understanding, connection, and global impact – welcoming guests and program participants from across the country and globe.

As we reflect on our history, we extend our thanks to the donors and partners recognized in this report. We also celebrate the dedication of our staff, past and present, and the unwavering support of HI USA’s Hostelling Legacy Society members, a special group of hostel supporters who have committed to leaving a lasting contribution to our mission through estate gifts.

This report is a celebration of legacy: a tribute to 90 years of opening our doors to millions of hostellers seeking a deeper understanding of the world and its diverse cultures through travel. We are excited about what lies ahead and look forward to your continued support as we work together to strengthen and enhance our mission for future generations.

90 Years of Opening Doors: A Hostelling Legacy

1930-1950s

Founding of Hostelling in the U.S. & American Youth Hostels (AYH)

While in Germany leading a student tour of Europe, Isabel and Monroe Smith meet the founder of hostelling, **Richard Schirrmann**.

Inspired by Schirrmann's vision, the Smiths bring hostelling to the U.S.

1934: The Smiths open the first American Youth Hostel in Northfield, MA.

1937: First interracial youth camp in the U.S. established at Hidden Villa Hostel, Los Altos, CA.

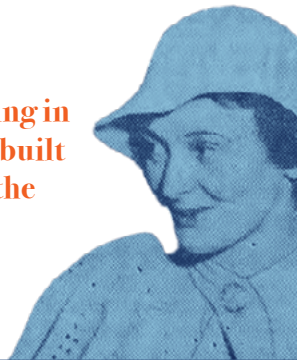
1955: American Youth Hostels is incorporated.

Hostelling expands across the country through homes and farmhouses, with "House Parents" overseeing operations.

1955: HI Martha's Vineyard opens

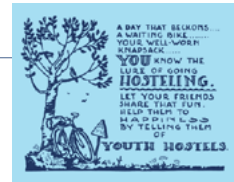

1960s-1970s

Recreation/Social Clubs & AYH Trips Program

The hostelling movement grows across the country through recreation and social clubs. AYH leads young people to Europe through the hugely popular "Trips Program."

Volunteer clubs expand across the country with biking, camping, and boat trips, while building hostelling awareness through newsletters and programs on travel and environmental issues. These clubs lead to the establishment of Councils chartered through AYH to grow hostelling.

1980s-'90s

Urban Hostel Openings & Partnerships

Partners provide key opportunities for hostel openings.

1980 & 1984: HI Point Montara & HI Pigeon Point hostels open in partnership with California State Parks.

1981: First urban hostel in partnership with the National Park Service (NPS), **HI San Francisco Fisherman's Wharf**, opens its doors in the Golden Gate National Recreation Area.

1989: Another urban hostel, **HI Los Angeles Santa Monica**, opens through partnership and funding from the California Coastal Commission and donors.

1990: HI New York City, the largest urban hostel in North America, opens on the Upper West Side of Manhattan.

1991-1997: HI San Francisco Downtown (1991), **HI Sacramento** (1995), and **HI San Diego Downtown** (1997) hostels open.

2000s

9/11 Changes the Face of Travel Forever; and HI USA responds

Occupancy across hostels in the U.S. hits record highs in the summer of 2001, and then the unthinkable happens. HI USA responds by deepening a commitment to the goals of peace and understanding through programming.

2000: HI Chicago, The J. Ira and Nikki Harris Family Hostel opens.

2001: The tragic events of 9/11 result in the senseless loss of lives and an extreme downturn in all tourism-related businesses, including hostelling.

2003: Recognizing that hostels are for everyone – regardless of age – AYH changes its name to **Hostelling International USA**.

2003: HI USA launches the “**Opening Doors, Opening Minds**” initiative aimed at countering stereotypes and encouraging global citizenry through Travel Scholarships, Cultural Kitchen, and Community Walls (cuisine-and art-based exchange programs).

2006: IOU Respect, a two-week cultural exchange program for young people, launches in response to the rising anti-Muslimism rhetoric post 9/11 in partnership with hostelling associations in Germany, France, Tunisia, Egypt, and Lebanon.

2010s

Unification & a New Trips Program

By 2010, Councils operating across the country are facing challenges to their financial sustainability. HI USA establishes a volunteer and staff task force to recommend the best way forward to sustain and grow hostelling in the future – resulting in “Unification.” Programming also evolves, using the foundation of success from Trips past.

2010: Great Hostel Give Back launches, giving free overnights to groups volunteering in local communities.

2011: Volunteer Representatives from 27 Councils vote to approve unification, consolidating the Councils and HI USA Central Office into one new nationwide hostelling organization.

2014: The process of unification is officially completed, and a new Board is seated.

2014: Drawing from the success of AYH’s Trips Program, **Explore America and Explore the World Travel Scholarships** are developed for young novice travelers who lack the means or opportunity to explore the U.S. and the world.

2020-Today

COVID changes the world, and again the face of travel. Heartbreaking decisions are made resulting in the loss of hostels, valuable staff, and volunteers. Despite a complete halt to social interaction, hostelling persists and re-emerges to provide the life-changing exchange experiences first introduced by Isabel and Monroe Smith.

2020-2022: 13 beloved hostels are closed permanently due to the impacts of COVID.

2020: HI USA Virtual Programs are established, providing meaningful opportunities for exchange and learning regardless of location.

2023: Explore the World Travel Scholarship: First Passport Edition is introduced, connecting young novice travelers with their first U.S. passports, a financial award, and a travel mentor to help break down barriers to international travel.

2024: HI USA is named **Best Hostel Chain in North America** at the Hostelworld Hoscars Awards.

2024: HI USA replaces its historic affiliate structure with a Hostel Referral program, promoting high-quality independent hostels across the U.S. to grow the hostelling movement.

Notes for FY24 Financial Results

The financial results for FY24 (April 1, 2023 – March 31, 2024) and the comparative totals for FY23 (April 1, 2022 – March 31, 2023) show moderate growth in overnights, after a sharp increase from pandemic lows in FY22. Strongest growth has been on the East Coast. West Coast hostels continue to struggle with weak demand.

Guest overnight stays increased to 647,421, up 6% from FY23, but still below the pre-pandemic high mark of 683,017 overnights.

Total operating revenue increased to \$48.7 million or 11% higher than FY23, with hostel operation revenues making up 90% of that total. Donations grew by 64% from the previous year, driven by a large bequest of over \$2 million and a 60% increase in investment interest income. Total operating expenses rose 20% with inflationary pressures, re-staffing to guest service expectations, and fully re-introducing hostel and signature programs.

Our surplus for the year (Change in New Assets) was \$2.5 million, increasing our net worth (Total Net Assets) in FY24 from \$53.9 million to \$56.4 million. The additional financial cushion will be important as we deal with an increasingly uncertain travel climate.
